DEFENSE THREAT REDUCTION AGENCY Contingency Operation(s): Operation Enduring Freedom/Operation Iraqi Freedom Operation and Maintenance, Defense-Wide Budget Activity 04, Administration and Service-Wide Activities

I. <u>Description of Operations Financed</u>: Balanced Survivability Assessments (BSA) identify and assess vulnerabilities in the United States and allied critical infrastructures, architectures or systems. The BSAs recommend changes in concepts or operations and technology solutions to mitigate vulnerabilities. They also provide continuing support to unit leadership to enable them to carry out a long-term investment strategy for risk management. The Defense Threat Reduction Agency (DTRA) is tasked to perform BSAs and vulnerability assessments by DoDD 5105.62, DoDD O-5100.30, DoDD S-5210.81, and CJCSI 5119.01B.

The Small Arms and Light Weapons (SALW) Program reduces proliferation by assisting foreign governments to improve security, safety and management of state-controlled stockpiles of Man-Portable Air Defense Systems (MANPADS), other small arms and light weapons, and conventional ammunition. Teams of DTRA experts provide foreign governments with assessments and technical advice as well as orientations to international best practices for the Physical Security and Stockpile Management (PSSM) of SALW. By securing and managing these assets, DTRA's efforts decrease the availability of weapons and ammunition to terrorists and insurgents, reduce regional exposure to destabilizing cross-border weapons transfers, and reduce the risk of catastrophic ammunition accidents.

a. <u>Narrative Justification</u>: Over the past three years, DTRA has supported U.S. Central Command's (CENTCOM) five year plan to conduct "all-threat" survivability assessments to ensure continued and enduring operation of the existing nuclear weapons command and control functions; global command, control, computers and intelligence; and the intelligence surveillance, and reconnaissance sector capabilities for the DoD. Additional information can be provided under CLASSIFIED cover.

Impact if not funded: This operation is to identify vulnerabilities to the infrastructure that, if not corrected, would significantly impact the ability to execute OIF. Deferring the BSA causes an operational impact. Unidentified mission vulnerabilities could significantly impact CENTCOM's ability to execute OIF.

2. 3.0 Operating Support Costs:001,3871,387800Small Arms and Light Weapons (SALW)

a. <u>Narrative Justification</u>: SALW proliferation threatens U.S. and coalition forces. Additional war funding for this requirement is necessary to meet increasing demands from Combatant Commands (COCOM) executing OEF/OIF missions and/or operating in global areas that are at high risk from the proliferation Man-Portable Air Defense Systems (MANPADS), the small but potent surface-to-air missiles preferred by terrorists. Excess weapons and ammunition stored in high-risk, poorly secured facilities could fuel terrorist and insurgent groups' capabilities, contribute to destabilizing regions, and hinder post-conflict OEF/OIF reconstruction and development. The SALW program assistance helps states improve the security and management of their arms and ammunition holdings, and the objectives of this program are an essential step in the process of restoring peace and stability in countries plagued with conflict and violent unrest.

The need for DTRA SALW expertise continues to increase as a result of the growing demand from COCOMs for SALW program assistance and the proliferation threat from MANPADS. The program needs war funding to continue to support OEF/OIF forces thru regional deterrence activities. The SALW Program has recently made great strides in U.S. Africa Command (AFRICOM) working with countries where arms security is paramount to controlling insurgent activities. In U.S. Pacific Command (PACOM), the program is just now opening the door to working with countries to address the problems created by the proliferation of Chinese weapons. South and Central America are experiencing the same problems as insurgent and terrorist groups continue to illegally pursue weapons from neighboring states. These activities put U.S. forces at risk along with threatening and destablilizing governments. The COCOMs clearly recognize the substantial

benefits of the SALW program, but without additional funding, the program will be unable to respond to their requests to increase the level of SALW program support.

Impact if not funded: The DTRA will be unable to respond to COCOM requests to increase the level of SALW assessments and training activities in support of Theater Security Cooperation (TSC) plans in current partner nations and new regions. The program will not be able to continue to build on its significant progress in AFRICOM nor be able to expand to other regional COCOMs requirements resulting in a negative impact on TSC plans and operations. The benefits of increased stability and security for partner nations achieved by this program far exceeds the investment.
