Major Headquarters activities captured in this exhibit include the Office of the Secretary of Defense, the Joint Staff, Headquarters of the United States Special Operations Command, Headquarters of the Defense Health Agency (DHA), and Headquarters of the Defense Agencies and Field Activities that manage the programs and operations of the Department of Defense.

The table above reflects estimated personnel levels and funding applicable to management headquarters activities between FY 2014 and FY 2015. During the development of the Fiscal Year (FY) 2015 budget request, the Department began an ongoing strategic effort to streamline management headquarters funding and staffing to realize efficiencies for better alignment and to provide support to a smaller military force.

The reported organizations in total net the following decreases from the FY 2014 budget estimates to FY 2015 estimates as a direct result of the Department's management headquarters efficiency efforts: (-5.4 percent) in military end strength, (-5.7 percent) in civilian full-time equivalents, and (-8.4 percent) in planned obligations. The Department is committed to continuing the review and refinement of management headquarters activities.
