<p>This internal reprogramming action transfers \$46 million from the New Horizons Exercise Transfer Fund to the Components' FY 1999 Operation and Maintenance appropriations to meet the most urgent contingency requirements consistent with the provisions and authority enacted by Public Law 106-31, the FY 1999 Emergency Supplemental Appropriations Act. This realignment does not change the purpose for which the funds were originally appropriated. This reprogramming is not reflected in the FY 2000 President's budget and does not affect Joint Military Intelligence Programs, Tactical and Intelligence Related Activities, or the National Foreign Intelligence Program.</p>
