<p>This internal reprogramming action transfers \$115.4 million from the Operation and Maintenance, Air Force, FY 1999, and Military Personnel, Air Force, FY 1999, appropriations to the Overseas Contingency Operations Transfer Fund (OCOTF). The purpose of this reprogramming action is to transfer funds that were previously transferred in Reprogramming Action FY 99-039 IR to fund costs in and around Kosovo back to the OCOTF. Transfer authority is provided in Public Law 106-31, the FY 1999 Emergency Supplemental Appropriations Act and is in addition to other transfer authorities. This realignment does not change the purpose for which the funds were originally appropriated. This action does not affect the National Foreign Intelligence Program, Tactical Intelligence and Related Activities (TIARA), or Joint Military Intelligence Programs (JMIP). This action is not reflected in the FY 2000 President's budget.</p>
