This action realigns funds from APAF to RDT&E,F to support the requirement to upgrade the Satellite Communications/Demand Assigned Multiple Access (SATCOM/DAMA) system in the B-2A aircraft with the Raytheon version of the Airborne Integrated Terminal (AIT). This action uses general transfer authority pursuant to section 8005 of Public Law 105-56, the FY 1998 Appropriations Act, and section 1001 of Public Law 105-85, the FY 1998 National Defense Authorization Act. It does not affect the Joint Military Intelligence Program (JMIP), the Tactical and Intelligence Related Activities (TIARA), or the National Foreign Intelligence Program (NFIP). It is not reflected in the FY 1999 President's Budget.

Explanation: The Airborne Radio Communications (ARC)-210 Terminals were to have been used to satisfy the SATCOM/DAMA radio requirements. These terminals did not win the source selection and additional RDT&E funds are now required to support development and integration efforts of the Raytheon version of the AIT, which is now being used. Software must be developed and updated to perform data conversion to 1553 compatibility, testing to ensure the AIT can survive the B-2 environment must be performed, and other technical challenges must be addressed. As a result, the total development cost has increased to \$87.45 million. To execute this effort, \$21.28 million must be reclassified from procurement to RDT&E. Procurement funds are available because the ARC-210 airborne terminals are no longer being procured to satisfy the SATCOM/DAMA requirements. Funds for the AIT procurement and initial spares will not be required until FY 2000.
