To transfer \$145.500 million from the Iraq Freedom Fund (IFF), 07/08, appropriation to the Operation and Maintenance, Defense-Wide 08/08, appropriation (\$102.800 million), and Procurement Defense Wide, 08/10, appropriation (\$42.700 million), for rapid acquisition of material and services to help resolve Immediate Warfighter Intelligence, Surveillance, and Reconnaissance (ISR) Needs. This transfer is pursuant to authority provided in Public Law 109-289, the Department of Defense (DoD) Appropriations Act, 2007, and Public Law 110-28, U.S. Troop Readiness, Veterans' Care Katrina Recovery, and Iraq Accountability Appropriations Act, 2007. This impacts the Military Intelligence Program (MIP).
