Description: This reprogramming would fund the construction of new Director of Public Works (DPW) buildings to replace the damaged Fort Buchanan DPW facilities. The new facilities will include an engineering/housing maintenance shop, administrative area, general purpose storage, oil storage, storage shed, and organization/non-organizational parking lot.

Justification: On 23 October 2009, a fuel farm just beyond the northeast perimeter fencing of Fort Buchanan, Puerto Rico (PR) had a catastrophic explosion. A total of 176 Army buildings and other infrastructure were damaged. The damage was most severe to the DPW complex that was closest to the boundary fence. It has been determined that it is not economically feasible to repair the DPW facilities, and thus, Army seeks to replace them. Section 2854 of Title 10 provides authority for the Army to replace the damaged facilities. As required by Section 2854, notification was provided to the congressional committees on or about May 18, 2010, to inform them of Army's intent to replace the facilities.

While the Governor of Puerto Rico is currently in litigation to revoke the permit to operate the fuel farm, the Army would like to build the new facility outside the fuel storage blast zone at another location on Ft Buchanan in an effort to ensure the protection of the life/health/safety of our soldiers and civilians. The new facility will comply with Energy Policy Act of 2005, Section 203 of the FY 2007 National Defense Authorization Act, and Executive Orders 13423 and 13514. In the meantime, ongoing DPW operations are being accomplished in converted classrooms on Fort Buchanan.

<u>Description</u>: This project constructs a new 9,600 square foot Large Vehicle Inspection Station (LVIS) to provide the proper secure area to conduct inspections of large vehicles prior to entering the installation. The project includes an entry control facility, parking, gatehouse, overwatch tower and modifications to the existing public roads. The inspection station will be outfitted with the new Vehicle Explosion Detection System (VEDS) and the Under Vehicle Surveillance System (UVSS) that require additional design features to address the radiological safety requirements of these systems.

Justification: The FY 2009 LVIS project at RAF Lakenheath was originally programmed at \$7.4 million. This action provides an additional \$5.7 million to adjust the location of a new access road, comply with radiological safety regulation, and offset the increase in local construction costs. Subsequent to design completion and during the bidding process, the United Kingdom planning conditions were laid into the project, and it was discovered that the new access road was to be constructed directly on top of a major host-nation communications line. The complexity and criticality of this communication line required that the new access road be relocated away from the construction site at a substantial cost to the project. Additional funds are required to construct the VEDS and UVSS in compliance with radiological safety regulations of the United Kingdom and United States. Finally, local construction costs have begun to increase due to the large scale construction effort associated with the 2012 Olympic stadium, supporting infrastructure, and facilities.
