<u>Description</u>: The \$1.7 million increase will allow Army to construct a six-foot high embankment on which the railroad will be placed and compensate for the discovery of contaminated soil at the construction site. The Lake Yard Railroad Interchange will include a railroad spur, siding, interchange to connect with existing Norfolk Southern Railroad, and an inspection building.

Justification:

This project was a FY 2009 Congressional insert and is not the product of the normal scope and cost development process. This project is needed to develop the Anniston Army Depot property at Highway 202. Additional funds are necessary to fund mandatory work items not considered during project planning, that are required to construct a complete and useable interchange with Norfolk Southern Railroad. Mandatory work includes constructing a six foot high embankment on which the rail road will be placed and specialized work processes for handling contaminated soil. Cost reduction measures were implemented in an effort to accommodate these additional costs within the funding provided. Cost reduction measures included the elimination of 900 linear feet (LF) of the railroad and 1,334 LF of fencing; however, sufficient savings were not generated. Thus, a Title 10, Section 2853 cost increase notification was sent to the congressional committees on or around October 20, 2011. An additional \$1.7 million is required to construct a complete and usable interchange.

If this project is not constructed, the installation will not be able to develop the property along Highway 202 to accommodate the future expansion required to support its mission as the combat vehicle rebuild center for the Army.

Description:

The \$7.6 million increase will allow the Army to award the remaining portions of the Aircraft Fuel Storage project, which includes a 365,000 gallon capacity fueling facility at Biggs Army Airfield, a 73,000 gallon capacity fueling facility at Oro Grande Range Camp, and a 65,000 gallon capacity fueling facility at Dona Ana Range Camp.

Justification:

Original cost estimates were based on historical data that did not consider the remote locations of these projects on the three distinct sites and the increased cost of labor, fuel and materials. The Army was only able to award a contract for 57% of the project scope within funding constraints. The Army awarded a \$9.8 million contract for the 365,000 gallon capacity fueling facility at Biggs Army Airfield, the highest priority fueling facility among the three planned fueling facilities. A Title 10, Section 2853 notification was provided to the Congressional Committees on or around December 27, 2010.

The remaining scope consists of a 73,000 gallon capacity fueling facility at Oro Grande Range Camp and a 65,000 gallon capacity fueling facility at Dona Ana Range Camp. Upon approval of this reprogramming request, the remaining two fueling facilities will be awarded. A Title 10, Section 2853 cost increase notification was provided to the Congressional Committees on or around October 20, 2011.

<u>Description</u>: Additional funds are needed to support the planning and design of the Aegis Ashore Missile Defense System Complex in Romania, which is part of the European Phased Adaptive Approach (PAA), Phase II.

Justification:

The Missile Defense Agency (MDA) is developing missile defense capabilities in phases focused on enhancing its capability against all ranges of ballistic missiles through the PAA. The European PAA, Phase II, provides a more robust defensive capability against short and medium range ballistic missiles by FY 2015.

The Aegis Ashore Missile Defense System Complex in Romania requires a total of \$15.2 million of planning and design funds to complete design activities and maintain project schedule. MDA has only \$9.5 million available for this purpose. This reprogramming request will provide the additional \$5.7 million of planning and design funds needed for this project to execute the European PAA, Phase II.
