Description:

This Barracks Complex project constructs a modified standard design barracks, a Brigade Headquarters and Battalion Headquarters to support the relocation of forces to Camp Humphreys as part of the Land Partnership Plan (LPP) international agreement. The primary facility includes barracks with elevators, brigade headquarters, battalion headquarters, special foundations, antiterrorism measures, and building information systems. The supporting facilities include underground utilities, heating via a dual fuel system, exterior lighting, paving, walks, curbs and gutters, fencing and gates, parking, dumpster pads, storm drainage, fuel storage tanks, information systems, and landscaping.

Justification:

This reprogramming action adds \$28.3 million to the project in order to award contracts to construct the brigade and battalion headquarters that have not yet been awarded because new standards for the construction of Sensitive Compartmented Information Facilities (SCIF) were issued after this project was authorized and appropriated.

On December 16, 2008, U.S. Forces Korea required compliance with new draft Intelligence Community Standard (ICS) for SCIF construction. Consequently, only the barracks, which does not contain a SCIF, was awarded on March 31, 2008; construction is now complete. The brigade headquarters, that contains a 10,000 square foot SCIF, and the battalion headquarters, that shares a common central utility plant (CUP), were not awarded due to the uncertainty arising from the draft SCIF standards that would impact these segments of the project.

On September 17, 2010, the Office of the Director of National Intelligence issued ICS 705-1, Physical and Technical Security Standards for SCIFs. ISC 705-1 standards apply to all future SCIFs and all those under construction as of the effective date of the standard. These new standards mandate the use of cleared U.S. construction contractors, the use of U.S.-manufactured

equipment and materials, and the employment of special security measures to safeguard construction activities.

Security measures also include the need to secure the construction site 24/7 using cleared American guards, the utilization of top secret-cleared and specially trained construction surveillance technicians, the presence of a full-time site security manager to manage all security aspects during construction; the institution of special inspection and storage procedures for all construction materials brought on site, and the special handling and secure shipping of materials from the production site to the construction site. A title 10 U.S.C. §2853 cost variation notification was sent to the congressional committees on May 25, 2012.
