Part III of this reprogramming action transfers \$28.258 million between various Defense FY 2011 appropriations. This reprogramming action uses \$26.0 million of general transfer authority pursuant to section 8005 of Division A of Public Law 112-10, the DoD Appropriations Act, 2011, and section 1001 of Public Law 111-383, the National Defense Authorization Act for FY 2011.

Explanation: Funds are required to support an upgrade to the Army's global network security infrastructure in support of the warfighter and operations in theater. As activities on the ground in Afghanistan evolve, force cap limits have caused commanders to allocate boots on the ground differently and manage certain critical war-fighting and business functions remotely. These remotely managed functions require a more robust and secure network capable of reaching back from the theater to the continental United States (CONUS). These functions include intelligence, logistics, personnel, financial management and command and control. Additionally, these upgrades would directly support and improve pre-deployment training and allow deploying units to seamlessly transition into theater starting in the 1st Quarter FY 2014. This investment establishes 11 regional security enclaves in CONUS and allows the Army to eliminate over 400 security stacks from the legacy network design in order to react to a global, asymmetric threat that is unconstrained by geographic boundaries. The Army and the Defense Information Security Agency (DISA) have partnered with a \$64 million investment in the United States Central Command (CENTCOM) for dramatically improved transport and regional security architecture supporting intra-theater operations. To best take advantage of this investment and improve the speed and capacity of CENTCOM split-based operations, a similar investment to upgrade the regional security architecture in CONUS is required. This enables deploying forces with virtual 'left-seat, right-seat' pre-deployment training, allowing commanders the ability to connect with the unit they are replacing for daily operational and intelligence updates prior to their actual arrival on the ground in theater. This is Title IX OCO budget requirement.
