<u>Description</u>: The project will provide a Strategic Communications Earth Station Operations, Satellite Communications (SATCOM) Repair and Utilities Facilities, and Command/Administration Support Center to support Joint Chiefs of Staff (JCS) command, control, communications and intelligence. The project will also include space for electronic equipment, operations and systems maintenance support areas, technical control center, network operations center, satellite repair facility, secure conference/training areas, technical library, loading docks, and antenna operating sites with cable trenches.

<u>Justification</u>: This project was initially awarded on August 30, 2011, within the Army's authority for \$39.3 million (103.76 percent of the appropriated amount). The project encountered several post award changes and delays that impacted the project schedule. Delays stemmed from unforeseen site conditions, design error, and complications with the utility plan. Numerous design modifications were identified by the U.S. Army Network Enterprise Technology Command (NETCOM). These modifications, combined with the site and utility changes, required a complete redesign of the facility.

Due to the mounting costs, the project team determined it was more financially advantageous to terminate the project. The contract was terminated for convenience (T4C) in March 2013. The facility was redesigned to meet all the emergent requirements and bids were re-solicited. The redesign and subsequent re-solicitation incorporate a modified floor plan that supports the legacy and new wideband, critical communications equipment. It also features a reconfigured site and civil plan, adjusts utility pathways, and includes landscaping that conserves water. This reprogramming will allow the Army to award the new contract and pay the T4C costs incurred.

The 10 U.S.C. § 2853 cost increase notification was sent to the congressional committees on January 24, 2014, reflecting a Current Working Estimate (CWE) of \$50.824 million.

<u>Description</u>: This project will provide a two lane access road and an access control point for Fort Belvoir, Virginia. Project will provide paving, truck and vehicle inspection canopies, a gatehouse, a search building, a search area shelter, a guard booth, an overwatch station, an ID check canopy, guardrails, and other traffic controls.

Justification: This project is required to provide access onto Fort Belvoir from US Route 1, reducing congestion and providing alternate access to the installation during periods of heightened force protection conditions. During project design, it was determined that a scope of work increase was required than was authorized in the approved DD Form 1391, based on updated standards for access control points. Congress authorized the additional scope through the FY 2013 National Defense Authorization Act (NDAA). The full required scope and a higher construction bidding climate have resulted in the current estimated cost for the project. The 10 U.S.C. §2853 cost increase notification was sent to the congressional committees on January 24, 2014, reflecting a current working estimate (CWE) of \$15 million.

<u>Description</u>: This project consists of a readiness center at Fort Buchanan for the Joint Forces Headquarters (JFHQ). The readiness center will provide adequate spaces for education areas, kitchen area, administration space, and special functional spaces. Supporting facilities will include military and privately owned vehicle parking, fencing, sidewalks, access roads and utilities.

Justification: The Readiness Center is required to house all elements of the JFHQ. This project will provide adequate space for the unit to complete their mission and achieve proficiency in their training. This project was designed with a base bid and 15 additive bid items and was solicited with restricted competition for the Small Business Set Aside, in accordance with the Office of the Principal Assistant Responsible for Contracting. With the restricted solicitation, proposals came in with higher bids than those typically received for the Army National Guard's military construction projects. In response to the higher than expected bids, the Army National Guard awarded the critical components of the project in order to begin construction within the appropriated amount of \$14.5 million. The 10 U.S.C. §2853 cost increase notification was sent to the congressional committees on January 9, 2014, reflecting a Current Working Estimate (CWE) of \$18.3 million. Additional funds in the amount of \$3.8 million are required to award the remaining project scope.
