This reprogramming action is submitted for prior approval because this action uses special transfer authority. This reprogramming action provides funding in support of higher priority items, based on unforeseen military requirements, than those for which originally appropriated; and are determined to be necessary in the national interest. This action meets all administrative and legal requirements, and none of the items have previously been denied by the Congress. This reprogramming action transfers \$500.0 million between FY 2014 Title IX Overseas Contingency Operations (OCO) Defense appropriations. This reprogramming action uses \$500.0 million of special transfer authority pursuant to section 9002 of Title IX OCO of division C of Public Law 113-76, the DoD Appropriations Act, 2014.

Explanation: Funds are required to support the President's decision that the Ebola outbreak is a national security issue and the United States needs to support the worldwide effort to bring the outbreak of Ebola in Africa under control. These additional funds are needed to provide humanitarian assistance in the Africa Command (AFRICOM) area of responsibility. Funds are required in anticipation of USAID Disaster Assistant Response Team requests to provide humanitarian assistance to West African countries impacted by the Ebola outbreak. The 2014 Ebola outbreak is one of the largest and most devastating Ebola outbreaks in history and the first in West Africa. Funds will provide urgent humanitarian assistance to meet requirements identified by the Centers for Disease Control (CDC), U.S. Agency for International Development (USAID), the Joint Staff, and U.S. Africa Command. Humanitarian assistance includes transportation of DoD and non-DoD (e.g., health care providers) personnel and supplies, furnishing of DoD and non-DoD supplies (e.g. isolation units, personnel protective equipment, and medical supplies to support treating Ebola patients), providing DoD and non-DoD equipment (e.g. temporary shelters to quarantine patients), and providing subject matter experts in training and education in support of sanitation and mortuary affairs functions to limit the spread and isolate the Ebola outbreak. In combination with the funding increase requested for the Overseas Humanitarian, Disaster Assistance, and Civic Aid, 14/15, appropriation in a previous reprogramming action (FY 14-14 PA), the Department would be prepared to devote up to \$1 billion to Ebola response efforts. These needs are deemed to be OCO requirements.
