This reprogramming action is submitted pursuant to section 102A(d) of the National Security Act of 1947, (50 U.S.C. § 3024 (d)), as added by the Intelligence Reform and Terrorism Prevention Act of 2004. **Part II** of this reprogramming action transfers \$14.859 million among Fiscal Year (FY) 2014 Air Force appropriations. This reprogramming action uses \$14.859 million of general transfer authority pursuant to section 8106 of division C of Public Law 113-76, the Department of Defense (DoD) Appropriations Act, 2014.

**Part III** of this reprogramming action transfers \$6.015 million between FY 2013 Air Force appropriations. This reprogramming action uses \$6.015 million of general transfer authority pursuant to section 8107 of division C of Public Law 113-6, the DoD Appropriations Act, 2013.
