This reprogramming action meets all administrative and legal requirements, and none of the items has been previously denied by the Congress.

This reprogramming action transfers \$342.378 million from the Operation and Maintenance, Navy, 21/21, appropriation to the National Defense Sealift Fund, Navy, 21/26, appropriation for proper execution. These funds are transferred pursuant to subsection (d) of Title 10 United States Code, section 2218.
