This reprogramming action transfers funds between appropriations for proper execution. The reclassification is required to execute funds properly in accordance with congressional intent. First, funds will provide MQ-9 multi-spectral depot repairs (\$12.3M) to include the labor and materials to repair at the contractor's depot repair facility. Also funds a significant share of depot repair being performed to cover overseas contingency operations and provides video imaging to aid aircrews with surveillance, reconnaissance, and weapons delivery. Next, funds the induction of 18 C-17 engines and the replacement of simulator projectors on legacy air vehicle systems (\$7M). Funding will also support the Air Force Weather Weapon System (AFWWS) capabilities via depot level contractor logistics support ensuring availability for 24/7 systems support and return-to-service actions (\$7.23M). AFWWS will meet requirements to support DoD mission planning and execution. Next, funds (\$18.5M) will support E-3 Airborne Warning and Control System (AWACS) Mission Crew Training Set Contractor Logistics Support and Performance Based Logistics. Lastly, funds will provide F-22 basic supply services to support 39,500 flying hours and weapon system sustainment material services (\$32.748M). This is a base budget requirement.
