This reprogramming action is submitted for prior approval because it uses general transfer authority pursuant to section 8005 of Public Law 110-116, the Department of Defense Appropriations Act, 2008; and section 1001 of Public Law 110-181, the National Defense Authorization Act for Fiscal Year (FY) 2008. This reprogramming action transfers \$5.7 billion among various military personnel appropriations to cash flow Army military personnel expenses to support the ongoing Global War on Terror (GWOT). Once the Congress appropriates funding to finance the FY 2008 Global War on Terror requirement, the Department will submit a reprogramming action to transfer funds back to the source appropriations. This action reprograms funding in support of higher priority items, based on unforeseen military requirements, than those for which funds were originally appropriated; and is determined to be necessary in the national interest. It meets all administrative and legal requirements, and none of the items has been denied previously by the Congress.
