SUBJECT: Interim Change to the DoDFMR, Volume 7A, Regarding  
Other Bonus Extension Authorities (DFAS Item L-19)

Attached is Interim Change 11-02 to Chapters 9 and 20 of the Defense Financial Management Regulation (DoDFMR), Volume 7A. It is effective December 28, 2001. This change extends the expiration date of special pay and bonus authorities for enlistment and reenlistment, for critical military skills retention and for aviation officer retention to December 31, 2002.

This is a routine change and the result of directed action that does not affect existing policies. A draft of this change was not provided for comment. Assignment of the interim change number is your authority to initiate a procedural modification to implement this change. Use the attached to initiate the formal change to the DoDFMR, Volume 7A.

**OTHER BONUS EXTENSION AUTHORITIES**

1. In paragraph 090104, change the date **December 31, 2001**, to read **December 31, 2002**.
2. In paragraph 090206, change the date **December 31, 2001**, to read **December 31, 2002**.
3. In paragraph 090406, change the date **December 31, 2001**, to read **December 31, 2002**.
4. In paragraph 2001, change the date **December 31, 2001**, to read **December 31, 2002**.
5. Change the bibliography for Chapter 09 as follows:

a. Under section 0901, delete the citation of **Public Law 106-398**, as this law has been codified in **37 U.S.C. 309**. Also, Add a new entry as follows:

b. Under section 0902, add the citation **DepSecDef Memo, November 18, 1999**, and delete as redundant, all the citations and listings for paragraphs **090201, 090201B1, 090201B3 and 090202**. Also, delete the citation of **Public Law 93-277**, as having been codified in **37 U.S.C. 308**. Under paragraph 090206, replace the citation of **Public Law 106-398**, with the following:

c. Under section 0904, delete the citation of **Public Law 106-398**, as this law has been codified in **37 U.S.C. 323**. Add a new entry as follows:

d. Under section 0905 and paragraph 090501, delete the citation of **Public Law 106-398**, as this law has been codified in both **37 U.S.C. 309(b)** and **37 U.S.C. 323(g)**. Move the citation of **37 U.S.C. 309(b)** from section 0905 to paragraph 090501 and to that paragraph reference add the citation **37 U.S.C. 308(d)**.

6. Change the bibliography for Chapter 20 section 2001, by replacing the citation of **Public Law 106-398** with the following:
