SUBJECT: Interim Change to the DoDFMR, Volume 7A, Regarding Other Bonus Authority  
Extensions (DFAS Item M-62)

Attached is Interim Change 48-03 to Chapters 9 and 20 of the Defense Financial Management Regulation (DoDFMR), Volume 7A. It is effective November 24, 2003. This change extends the authority to pay special pay and bonuses for enlistment and reenlistment, for critical military skills retention and for aviation officer retention to December 31, 2004.

This is a routine change and the result of directed action that does not affect existing policies. A draft of this change was not provided for comment.
