SUBJECT: Interim Change to the DoDFMR, Volume 7A, Regarding Pay and Allowances
Which May Be Alloted, Disposable Pay, and Precedence of Pay Deductions and
Collections (DFAS Item L-55)

Attached is Interim Change **49-02** to Chapters 41, 50, and 52 of the Defense Financial Management Regulation (DoDFMR), Volume 7A. This change revises the items of pay and allowances which may be alloted, deletes dependent dental plan and/or Tricare Family Member Dental Plan throughout Chapter 50 and Table 52-1, and changes Table 52-1, Rule 4, Item g description. The effective date of this change is immediate.

This is a routine change and the result of directed action that does not affect existing policies. A draft of this change was not provided for comment. Assignment of the interim change number is your authority to initiate a procedural modification to implement this change. Use the attached to initiate the formal change to the DoDFMR, Volume 7A.

4. Delete Item “ d. TRICARE Family Member Dental Plan” under Rule 2 of Table 52-1 and re-designate item e as d.

5. Revise Item “g. Subsistence charges” under Rule 4 of Table 52-1 to read:

“g. Meal collections”
