Imminent Danger Pay For Vietnam, Laos, Cambodia, and
El Salvador, (DFAS Item G-31)

Attached is DFAS Interim Change 22-97 to Chapter 10 of the
DoDFMR, Volume 7A. It is effective July 15, 1997.

This change terminates the designations of Vietnam and Laos
and modifies the designations for El Salvador and Cambodia.

IMMINENT DANGER PAY FOR VIETNAM, LAOS, CAMBODIA AND EL SALVADOR

1. Make the following changes to existing designated hostile fire or imminent danger pay areas in Figure 10-1:
 - a. Under Cambodia, terminate the existing designation as of "14 Jul 1997". Insert a new designation, "(2) Land area" with an effective date of "15 Jul 1997".
 - b. Under El Salvador, terminate the existing designation as of "14 Jul 1997". Insert a new designation, "(2) Land area, except Compalapa International Airport and Ilopango Air Base" with an effective date of "15 Jul 1997".
 - c. Terminate the existing designation for Laos with an effective date of "15 Jul 1997".
 - d. Terminate the existing designation for Vietnam with an effective date of "15 Jul 1997".
2. Update the bibliography for Chapter 10 as follows:
 - a. Insert new entries for "Cambodia" and "Laos". Use the citation: "ASD(FMP) Memo, 15 Jul 1997" for both entries.
 - b. Under the existing entries for "El Salvador" and "Vietnam" include the citation: "ASD(FMP) Memo, 15 Jul 1997" for both entries.
