
SUBJECT: Update to the Department of Defense Financial Management Regulation (DoDFMR) Volume 7, Part B, Non-Regular Service Retirement Eligibility-Minimum Required Reserve Service (DFAS Item F-89)

This is an Interim Change Number RS - 97 to the DoDFMR, Volume 7B. This change is effective immediately.

"(3) Has performed the last 8 years of qualifying service as a member of any category named in 10 U.S.C. 12732(a)(1) but not while a member of a Regular component, the Fleet Reserve or the Fleet Marine Corps Reserve (Note: The 8-year period is reduced to 6 years for the period 5 Oct 1994 through 30 Sep 1999.); and"

2. Table 1-1-4, Note 1, revise to read:

"1. Who performed last 8 years (6 years during the period 5 Oct 1994 through 30 Sep 1999) of qualifying service as a member of a Reserve or National Guard component."

3. Add the following additions to the bibliography of Part One, Chapter 1:
