MEMORANDUM FOR DIRECTOR, MILITARY PAY OPERATIONS, DEFENSE FINANCE AND ACCOUNTING SERVICE (DFAS-PM/CL)

SUBJECT: Interim Change to the Department of Defense Financial Management Regulation (DoDFMR), Volume 7, Part B, Regarding Increase in Annual Limit on Inactive Duty Training Points for Reserve Retirement (DFAS Item K-6)

The attached, Interim Change **R 13-01** to Chapter 1 of the DoDFMR, Volume 7B is effective October 30, 2000. This change incorporates Public Law 106-398, Section 652, October 30, 2000, which increases the maximum number of reserve retirement points that a reservist may accrue toward retirement in any year from 75 to 90.

We have evaluated your comments on the proposed change and included your comments where appropriate. Assignment of the interim change number is your authority to initiate procedural modifications to implement this change. Use the attached to initiate the formal change to the DoDFMR, Volume 7B.

1. Paragraph 010107.B.3, revise to read:

“3. One day for each point, but not more than 90 days in any one-year period on or after October 30, 2000, credited for attendance at drills or periods of equivalent instruction prescribed for that year by the Secretary concerned that conform to requirements by law or are credited as service in the Health Professionals Scholarship and Financial Assistance Program under 10 U.S.C. 2126 (reference (c)). Between September 23, 1996, and October 29, 2000, the maximum number was 75 days, and 60 days before September 23, 1996. The credit includes points at the rate of 15 per year for membership in a Reserve Component of an Armed Force, in the Army or the Air Force without component, or service in the following categories before July 1, 1949:”

2. Paragraph 010108.A.1, revise to read:

“1. Years of service before July 1, 1949, in”

3. Paragraph 010108A.1.j.(1), revise to read:

“(1) The dietetic or physical therapy categories if the service was performed after April 6, 1917, and before April 1, 1943, or”

4. Paragraph 010108.A.2.e., revise to read:

“e. Members whose anniversary year closed on or after October 30, 2000, may be credited with up to 90 inactive duty points (vice 75 inactive duty points between September 23, 1996, and October 29, 2000, and 60 inactive duty points before September 23, 1996).”

5. Paragraph 010108.B., revise to read:

“B. A member of the Armed Forces or National Guard is entitled to retired pay computed under Table 3-1, Rule 14, for non-regular service upon application if he or she:”

6. Paragraph 010301.B.4.c., revise to read:

“c. One day for each point, but not more than 90 days in any 1-year period on or after October 30, 2000, credited for attendance at drills or periods of equivalent instruction prescribed for that year by the Secretary concerned that conform to requirements by law or credited as service in the Health Professionals Scholarship and Financial Assistance Program under 10 U.S.C. 2126 (reference (c)). Between September 23, 1996, and October 29, 2000, the maximum number was 75 days, and 60 days before September 23, 1996. The credit includes points at the rate of 15 per year for membership in a Reserve Component of an Armed Force, in the Army or the Air Force without component, or service in the following categories before July 1, 1949:”
