The realignment of these amounts funded unplanned classified operational costs.
- BA-01 Baseline - 1PLV-Operational Support +\$6,994 thousand realigned from 1PLR-Theater Forces -\$6,994 thousand. The realignment of these amounts funded support for emergent theater operations.
- BA-01 Baseline - 1PLV-Operational Support +\$4,197 thousand realigned from 1PLM-Management/Operational HQtrs -\$4,197 thousand. The realignment of these amounts funded leased modular facilities for Joint MISO Operations including purchase and installation of equipment and furnishings.

The DFAS September 1002 included \$1,544 thousand in obligations identified as undistributed or inidentified by BA and Budget Line Item (BLI). Based on analysis of underlying feeder systems and Advana data, the undistributed amount of \$1,544 thousand was properly allocated to 1PLR - Theater Forces. The same analysis identified an additional \$2,149 thousand in obligations that were incorrectly mapped to 1PLM - Management/Operational HQtrs and adjusted to correctly reflect the obligations in 1PLR - Theater Forces. USSOCOM continues to work with DFAS to minimize mapping issues. It should also be noted that FY23 mapping issues or inaccuracies appeared to be significantly less than experienced in FY 2022. USSOCOM continues to work with DFAS to research 1002 SAG discrepancies in FY23 to resolve for reporting purposes in future fiscal years.

Obligation amounts are reported by the accounting systems in their trial balances and are approved each month and certified at year end. However, the mapping to the BLI/SAG does not happen in the accounting systems (especially legacy accounting systems). Mapping to the correct BLI/SAG is done in the Defense Departmental Reporting System and is one of the primary causes for the inaccurate and over obligation reporting on the September 1002. Funds control is also not performed at the BLI/SAG level in the accounting systems which further complicates the reporting and mapping to BLI/SAG.
