#### **I. Description of Operations Financed:**

As ordered by the President and pursuant to the Secretary of Defense's issuance of Military Commission Order Number 1 on March 21, 2002, the Office of Military Commissions was established under the Defense Legal Service Agency (DLSA) to facilitate preparation for and trial of cases before military commissions. The Office of Military Commissions is responsible for the appointing authority function, the prosecution function, and the defense function. In addition, appellate review panels are mandated.

The Office of Military Commissions is a component of DLSA with the mission to deal with the trials of enemy combatants who violate the laws of war. It is comprised of four sections:

- 1) The appointing authority (similar to a convening authority), which includes the Office of the Legal Advisor,
- 2) The prosecution office,
- 3) The defense office, and
- 4) The Review Panel (judges who consider appeals).

The OMC has a total of 93 military personnel and 51 temporary full-time-equivalent civilian positions.

The Supreme court required the enactment of legislation to continue the OMC process; the Military Commissions Act (MCA) was the enacted response. The President recently announced that several major terrorists have been transferred to GTMO and will be tried under the MCA statutory framework. These highly publicized events are expected to occur in FY 2007.

Tribunals are now in their initial stages, with ten cases presently referred for trial. Some are in various stages of collateral constitutional litigation. All customary expenses required to operate a government activity are financed, including salaries and benefits, travel, rental of office space, rental of equipment, communications, and the cost of supplies and equipment. The OMC is expected to last a number of years and encompass heavy logistical and travel costs. The OMC needs sustained supplemental funding to accomplish its mission.

**Narrative Justification:** Personnel support costs for support of Guantanamo Bay, Cuba operations cover temporary duty (TDY) costs for the OMB personnel to meet with their detainee clients and when commission hearings are scheduled. The courtroom is located at Guantanamo as well as a satellite office which require funding.

Public Law 108-289, Making Appropriation for the Department of Defense for the fiscal year ending September 30, 2007, Title IX, Additional Appropriations, provided the full requirement (\$4.0 million) for the TAD program in FY 2007.

**Impact if not funded:** Without funding for travel/support costs, DLSA would not be able to fulfill the President’s order to try cases which will arise.

**Narrative Justification:** Every time counsel travels to converse with a detainee client, an interpreter is necessary for non-English speaking detainees. Funding provides for an interpretation and translation contract.

Public Law 108-289, Making Appropriation for the Department of Defense for the fiscal year ending September 30, 2007, Title IX, Additional Appropriations, provided the full requirement (\$7.0 million) for the operating support cost program in FY 2007.

**Impact if not funded:** Without funding for operating support costs, DLSA would be unable to fulfill the President's order to try cases which will arise.
