## **Overall Troop-Level Assumptions**

- Boots-on-the-ground (BOG) Drawdown to 9,800 by end of December 2014
- Budget assumes 9,800 through end of September 2015
  - Decrease to about 5,000 by <u>Dec 2015</u>
  - Decrease to normal embassy presence by Dec 2016
- In-theater support slightly increases to support DoD's forward presence around the Middle East
- In-CONUS/other mobilization decreases as expected


# **FY 2015 Budget Amendment**


## FY 2015 Approach

- Incremental operational costs related to the war effort
- Focuses on ending combat mission in Afghanistan
- Supports forward presence
- Retrograde of equipment, facilities/bases, people
- Reset/reconstitution for equipment and munitions
- International support programs:
   Coalition Support; Lift and Sustain;
   to include follow-on Iraq activities
- Presidential Initiatives

## **Counterterrorism Partnerships Fund**

The Counterterrorism Partnerships Fund (CTPF) builds on existing tools and authorities to respond to a range of terrorist threats and crisis response scenarios. The CTPF has three broad purposes:

- Counterterrorism Support
  - Build Partner Capacity
  - Augment U.S. Capacity to Support Partners in CT Operations
- Syria Regional Stabilization Initiative
- Crisis Response

Preliminary Allocations by CTPF Category

Categories	FY 2015 Estimated
Counterterrorism Support	2,500
Syria Regional Stabilization Initiative	1,000
Crisis Response	500

The CTPF would be established as a fund to permit DoD – after congressional notification – to transfer CTPF monies to traditional DoD accounts for execution of approved initiatives. The amounts shown above could change based on world events and resulting needs.

## **Examples of Possible CTPF Initiatives**

- Partner-nation efforts:
  - Horn of Africa (Somalia, Kenya, Ethiopia, Uganda, Burundi, Djibouti) (\$300M)
  - North/West Africa (Nigeria, Niger, Libya, Tunisia, Morocco, Chad, Cameroon, Mauritania) (\$200M)
  - > Yemen (\$200M)
- Increased Intelligence, Surveillance, and Reconnaissance (\$470M)
- Increased rotary wing support to SOF (\$210M)
- Maritime support to SOF (\$90M)
- Global Lift & Sustain for Allied Partners conducting CT ops (\$150M)
- Naval CT enablers (\$100M)

## **European Reassurance Initiative**

Through the European Reassurance Initiative (ERI), DoD seeks to reassure our NATO allies and bolster the security and capacity of our partners. The ERI has five primary lines of effort:

- Increased U.S. military presence in Europe
- Additional bilateral and multilateral exercises and training with allies and partners
- Improved infrastructure to allow for greater responsiveness
- Enhanced prepositioning of U.S. equipment in Europe
- Intensified efforts to build partner capacity for newer NATO members and other partners

## Preliminary Allocations by ERI Category

Additional exercises and training	75
Improved infrastructure	250
Enhanced prepositioning of U.S. equipment	125
Intensified efforts to build partner capacity	35

The ERI would be established as a fund to permit DoD – after congressional notification – to transfer ERI monies to traditional DoD accounts for execution of approved initiatives.

## **Examples of Possible ERI Initiatives**

- Armored Brigade Combat Team (ABCT) presence (\$260M)
- Allied deployments in Black Sea (\$13.5M)
- Baltic Air Policing (\$20M)
- Deploy land forces to train with Moldova and Georgia (\$7M)
- NATO exercises (\$16M)
- Increase range capabilities and upgrade training sites in Bulgaria (\$115M)
- Weapons storage at Camp Darby, Italy (\$47M)
- Increased Partnership Activities in Central and Eastern Europe (\$10M)
