I. Description of Operations Financed:

The Support for International Sporting Competitions (SISC) Defense account is funded with a no-year appropriation that provides continuing Department of Defense (DoD) support to national and international sporting events that are either certified by the Attorney General or support specific organizations, such as; the Special Olympics, Paralympics, and the United States Olympic Committee's (USOC) Paralympic Military Program.

Funds are still available from the FY 2015 and FY 2023 Department of Defense (DoD) Appropriations Acts. The Department is not requesting additional appropriated funds for FY 2024. In FY 2022 the Department supported 22 sporting events with a cost of \$0.9 million. In FY 2023, the Department plans to support the following events: the Special Olympics Summer Games; the United States (U.S.) Paralympic National Championships for Athletics; Cycling and Swimming; and around 18 Paralympic Military Program competitions. These events are estimated to cost \$1.5 million in FY 2023. Additionally, the program intends to procure life cycle replacement of the communications equipment, which is an estimated cost of \$3.5 million. In FY 2024, the Department intends to support around 24 sporting events with an estimated cost of \$2.4 million, from the unexpended balances from the FY 2023 DoD Appropriation Act.

These funds support safety, security and logistical requirements for certain sporting competitions. Under the provisions of 10 U.S.C., Section 2564, the Department has the authority to assist Federal, State or local agencies in support of civilian sporting events if the Attorney General certifies that such assistance is necessary to meet essential security and safety needs.

The Department can also provide support to the Special Olympics, the Paralympics, a sporting event sanctioned by the U.S. Olympic Committee, through the Paralympic Military Program, and any national or international Paralympic sporting event that meet requirements outlined in 10 U.S.C. Section 2564, as amended by Public Law (P.L.) 110-181 Section 372. Support for these events does not require Attorney General certification.
