<p>This reprogramming transfers \$6.338 million from Research, Development, Test, and Evaluation, Navy, 99/00, to Research, Development, Test and Evaluation, Defense-Wide, 99/00, so that all Chemical/Biological funds will reside in a Defense-Wide appropriation, consistent with Public Law 103-160. It does not change the purpose for which the funds were originally appropriated. This action uses general transfer authority pursuant to section 8005 of Public Law 105-262, the DoD Appropriations Act, 1999, and section 1001 of Public Law 105-261, the Strom Thurmond National Defense Authorization Act for FY 1999. This action does not affect Tactical Intelligence and Related Activities (TIARA), Joint Military Intelligence Programs (JMIP), or the National Foreign Intelligence Program (NFIP). This reprogramming is not reflected in the FY 2000 President's budget.</p>

<p><u>Explanation:</u> The Congress added funds in the Research, Development, Test, and Evaluation, Navy, 99/00, appropriation for both the Chemical and Biological Incident Response Force (CBIRF) Small Unit Biological Detector and the Chemical Dosimeter programs, which are congressional special interest items. The Joint Program Office for Biological Defense is the Milestone Decision Authority for fielding the CBIRF upon maturation of the technology. Therefore, a reprogramming is necessary to execute these funds in the Chemical and Biological Defense Program. The amount for reprogramming has been adjusted for congressional undistributed reductions.</p>
