<p>This internal reprogramming action realigns \$19.0 million of congressional increases to the Defense Health Program (DHP) for medical research efforts from the Operation and Maintenance (O&M) budget activity to the Research, Development, Test and Evaluation (RDT&E) budget activity for proper execution. This transfer does not represent a change from the purpose for which the funds were originally appropriated. This action uses general transfer authority pursuant to section 8005, Public Law 105-262, the FY 1999 DoD Appropriations Act, and section 1001 of Public Law 105-261, the Strom Thurmond National Defense Authorization Act for FY 1999. This action does not affect Joint Military Intelligence Programs (JMIP), Tactical Intelligence and Related Activities (TIARA), or the National Foreign Intelligence Program (NFIP). This action is not reflected in the FY 2000 President's budget.</p>

<p><u>Explanation:</u> In FY 1999, the Congress provided additional O&M resources to the DHP appropriation to fund the following medical research programs: Ovarian Cancer Research (\$10.0 million), Post-Polio Syndrome Research (\$1.0 million), Molecular Genetics Research (\$3.0 million), Epidermolysis Bullosa (\$1.0 million), and Nervous System Studies (\$4.0 million). These efforts are research and development activities and should be funded in that budget activity accordingly. Therefore, this reprogramming action transfers these funds to the DHP Research, Development, Test, and Evaluation budget activity for proper execution.</p>
