<p>This reprogramming action transfers \$3.0 million from Other Procurement, Navy, 99/01, and \$3.0 million from Other Procurement, Air Force, 99/01, to Research, Development, Test, and Evaluation, Navy, 99/00, to properly execute the funds. This action uses general transfer authority pursuant to section 8005 of Public Law 105-262, the DoD Appropriations Act, 1999, and section 1001 of Public Law 105-261, the Strom Thurmond National Defense Authorization Act for FY 1999. This transfer does not change the purpose for which funds were originally intended, and is not reflected in the FY 2000/2001 President's budget. This action does not affect Joint Military Intelligence Programs (JMIP), Tactical Intelligence and Related Activities (TIARA), or the National Foreign Intelligence Program (NFIP).</p>
