<p>This internal reprogramming action transfers \$4.0 million to the appropriate accounts to support military funeral honors. In accordance with section 1491 of Title 10, U.S.C., the Services shall provide military funeral honors, upon request, for the funeral of any eligible veteran. Funds will be used to pay for a \$50 stipend in the new reserve/guard duty status as defined in section 12503 of Title 10 U.S.C. or section 115 of Title 32, U.S.C. This transfer does not change the purpose for which the funds were originally appropriated. This action requires the use of general transfer authority, pursuant to section 8005 of Public Law 106-79, the DoD Appropriations Act, 2000; and section 1001 of Public Law 106-65, the National Defense Authorization Act for FY 2000. It meets all administrative and legal requirements of the Congress and has not previously been denied by the Congress.</p>
