This action uses general transfer authority pursuant to section 8005 of Public Law 106-79, the DoD Appropriations Act, FY 2000, and section 1001 of Public Law 106-65, the National Defense Authorization Act for FY 2000. Reclassification is required to properly execute funds in accordance with congressional intent. This realignment does not change the purpose for which the funds were originally appropriated, meets all administrative and legal requirements of the Congress, and has not previously been denied by the Congress.</p>

To be consistent with prior execution and to accomplish the intent of the Congress, this program is more appropriately executed in the Operation and Maintenance, Defense-Wide appropriation. The amount being transferred is available for reprogramming without impact to the approved Operation and Maintenance, Navy program.</p>
