This action is submitted for prior approval of a new start program within the Aircraft Procurement, Air Force, 00/02, appropriation for procurement of 251 Air-to-Air Interrogator (AAI) modification kits. The total procurement cost is \$127.4 million. The Air Force provided congressional notification on June 3, 1999, for the Research and Development effort of this program. This action meets all administrative and legal requirements of the Congress and has not previously been denied by the Congress. This action is reflected in the FY 2001 President's Budget.

Explanation: The AAI is an Identify Friend or Foe (IFF) system that integrates the functions of the IFF transponder, interrogator, and secure mode computers into a single unit. This system enables the F-16 Block 50/52 to properly perform its force protection mission, accurately identify the multinational friendly aircraft they are protecting, and attain a usable combat identification solution, enabling the Beyond Visual Range employment of AMRAAM, when combined with other onboard sensors. This capability is critical for ensuring optimum adherence to rules of engagement without diminishing combat capability. The following table provides the funding amount by fiscal year, the procurement profile, and the installation schedule. The schedule allows concurrent modification with 5 other modifications.
