This reprogramming action is submitted for prior approval because it uses general transfer authority, pursuant to section 8005 of Public Law 106-79, the DoD Appropriations Act, 2000; and section 1001 of Public Law 106-65, the National Defense Authorization Act for FY 2000. It reprograms funding in support of a higher priority item, based on unforeseen military requirements, than that for which the funds were originally appropriated. This action will provide funding for the completion of the Future Scout and Cavalry System (FSCS) Advanced Technology Demonstration. This action meets all administrative and legal requirements of the Congress and has not previously been denied by the Congress. The action also involves an item of congressional special interest. This action was not reflected in the FY 2001 President’s Budget.

Completion of the FSCS Advanced Technology Demonstration will occur in FY 2002 as currently planned.
