This action transfers \$45.0 million from the Overseas Contingency Operations Transfer Fund to Procurement of Ammunition, Navy and Marine Corps, 01/03, to be used for critical readiness or sustainability needs. Munitions included are based on the recommendations of the Joint Requirements Oversight Council. This transfer is made pursuant to transfer authority contained in Public Law 106-31, the 1999 Emergency Supplemental Appropriations Act. This realignment does not change the purpose for which the funds were originally appropriated.



Explanation: This transfer provides funds to procure additional Joint Direct Attack Munitions, in accordance with the Department's November 1999 report to Congress which provided information and emergency designation of funding appropriated in the 1999 Emergency Supplemental Appropriations Act to the Overseas Contingency Operations Transfer Fund. That report specified that \$81.3 million would be used to purchase Navy Joint Direct Attack Munitions. The Department transferred \$36.3 million for that purpose during FY 2000. The remaining \$45 million was not transferred, pending approval of full rate production status for the 2,000 pound JDAM variant, which occurred on March 23, 2001. Accordingly, this action transfers \$45 million to Procurement of Ammunition, Navy and Marine Corps, 01/03, to meet critical readiness and sustainability needs.
