

This reprogramming action transfers \$4.453 million from Drug Interdiction and Counter-Drug Activities, Defense, FY 2001, to the Army and Navy for drug interdiction and counter-drug activities consistent with the provisions of Public Law 106-259, the Department of Defense Appropriations Act, 2001. This transfer authority is in addition to other transfer authorities. Realignment of funds between counter-drug projects may be accomplished only with prior approval of the Office of the Under Secretary of Defense for Policy, Drug Enforcement Policy and Support (DEP&S).
