This reprogramming action is submitted for prior approval since it uses general transfer authority, pursuant to Section 8005, Public Law 107-117, the DoD Appropriations Act, 2002; and section 1001 of Public Law 107-107, the National Defense Authorization Act for FY 2002. This action transfers \$5.7 million from the Research, Development, Test, and Evaluation, Army, 02/03, appropriation to the Missile Procurement, Army, 02/04, appropriation. It meets all administrative and legal requirements of the Congress, and the Congress has not denied any of the items.

Explanation: Section 8050, Public Law 107-248, the DoD Appropriations Act, 2003, rescinded \$37.650 million from the Missile Procurement, Army 02/04, appropriation of which \$13.2 million was intended as a rescission to the TOW Fire and Forget program. This program is actually funded in the Research, Development, Test and Evaluation, Army 02/03 appropriation. The Army Tactical Missile System Block II (ATACMS BLK II) program has been terminated by the Army in order to fund transformation and other higher priority programs. Therefore, \$7.5 million is available in ATACMS to comply with the rescission, and the remainder, \$5.7 million, must be transferred to ATACMS to correctly align the rescission to the Missile Procurement, Army appropriation.
