**This action supersedes internal reprogramming action, FY 04-09 IR, which cited section 8005 of Public Law 108-87, the DoD Appropriations Act, 2004. The only purpose of this action is to change the authority, citing section 126 of Title 10, United States Code.**

This action transfers funds in two parts. **Part I** transfers \$70.857 million from Operation and Maintenance, Army, 04/04, appropriation, and \$16.352 million from Operation and Maintenance, Navy, 04/04, appropriation to the Operation and Maintenance, Defense-Wide, 04/04, appropriation for proper execution. **Part II** transfers \$.338 million from Other Procurement, Navy, 04/06, appropriation to Procurement, Defense-Wide, 04/06, appropriation for proper execution. This action documents the transfer of funds, pursuant to section 126 of Title 10, United States Code to comply with section 527, Public Law 107-107, the National Defense Authorization Act for FY 2002. This action does not change the purpose for which the funds were originally appropriated. It meets all administrative and legal requirements of the Congress and the Congress has not denied any of the items.



Explanation: The National Defense Authorization Act for FY 2002 (P.L. 107-107) section 527 directs that professional development funding in FY 2003 (and the outyears) for the National Defense University (NDU), including the Joint Forces Staff College (JFSC), would be provided under Operation and Maintenance, Defense-Wide appropriation. In order to meet the intent of that legislation, FY 2004 funds for NDU/JFSC must be moved from the Operation and Maintenance, Army and Operation and Maintenance, Navy appropriations to Operation and Maintenance, Defense-Wide appropriation for proper execution.
