This reprogramming action transfers \$36.5 million from the Iraq Freedom Fund (IFF), 04/05, appropriation to Procurement, Marine Corps, 04/05, appropriation. These funds will be used to procure items that are considered essential to improving the safety and security of U.S. Forces in Iraq. This transfer authority is contained in the Emergency Supplemental Appropriations Act for Defense and for the Reconstruction of Iraq and Afghanistan, 2004, Public Law 108-106.
