This reprogramming action is submitted in two parts. **Part I** transfers \$126.0 million from the Iraq Freedom Fund, 03/04, appropriation to Operation and Maintenance, Army, 04/04, appropriation. This transfer authority is contained in Public Law 108-11, the Emergency Wartime Supplemental Appropriations Act, 2003. **Part II** transfers \$395.0 million from the Iraq Freedom Fund, 04/05, appropriation to Operation and Maintenance, Army, 04/04, appropriation. This transfer authority is contained in Public Law 108-106, the Emergency Supplemental Appropriations Act for Defense and for the Reconstruction of Iraq and Afghanistan, 2004. These funds will be used to fund increased operational tempo in Iraq, in-theater equipment maintenance, and transportation of supplies and equipment. It meets all the legal and administrative requirements of the Congress, and the Congress has not denied any of the items.
