This reprogramming action transfers \$44.639 million from Drug Interdiction and Counter-Drug Activities, Defense, FY 2004, appropriation, consistent with the provisions of Public Law 108-87, the Department of Defense Appropriations Act, 2004. This transfer authority is in addition to other transfer authorities provided by that Act. Realignment of funds between counterdrug projects may be accomplished only with prior approval of the Office of the Under Secretary of Defense for Policy, Counternarcotics (CN).
