This reprogramming action transfers \$13.5 million from the Iraq Freedom Fund, 04/05 and \$19.3 million from the Iraq Freedom Fund, 04/06, appropriation to the Other Procurement, Army, 05/07, appropriation (\$8.4 million) and the Operation and Maintenance, Army 05/05, appropriation (\$24.4 million) to support the Improvised Explosive Devices (IED) Task Force. The Emergency Supplemental Appropriations Act, 2004 (Public Law 108-106) and Title IX of the Department of Defense Appropriations Act, 2005 (Public Law 108-287) requires the Secretary of Defense to notify the congressional defense committees not fewer than 5 days prior to making transfers from the IFF.

FY 2005 REPROGRAMMING INCREASES: **+32,800**

Other Procurement, Army, 05/07 **+8,443**

Budget Activity 1: Tactical and Support Vehicles **+2,876**

Funds will be used to construct two prototype IED "Hunter/Killer" teams for proof of concept testing in Iraq. Each team will consist of one enhanced RG31 Medium Mine Protection vehicle (Hunter) and one enhanced Buffalo (Killer) Explosive Ordnance Disposal vehicle outfitted with state-of-the-art detection and electronic countermeasure systems.

Budget Activity 2: Communications and Electronics Equipment **+4,700**

These funds are to be transferred to the Other Procurement, Army account to procure 300 low-power WARLOCK Red Electronic Countermeasures systems.

Budget Activity 3: Other Support Equipment **+867**

These funds are to be transferred to the Other Procurement, Army account to increase Multi-National Force (MNF) capability to collect technical intelligence and provide dedicated all source intelligence fusion in order to target bomb maker networks.

Operation and Maintenance, Army, 05/05 **+24,357**

Budget Activity 1: Operating Forces **+24,357**

These funds are to be transferred to the Operation and Maintenance, Army account to increase Multi-National Force (MNF) capability to collect technical intelligence and provide dedicated all source intelligence fusion in order to target bomb maker networks. rapidly pinpoint common indicators of Improvised Explosive Devices and contribute to the commander's dominant situational awareness. Funds required for the initial phase include: contractor support (\$12.4 million), deployment costs (\$0.9 million), equipment (\$5.1 million), and training (\$0.7 million). Funds are also for fingerprint searching and identity vetting, smart card applications, document scanning and Data Conversion and in support of the Hunter/Killer proof-of-concept testing in Iraq (\$5.2 million).
