This reprogramming action is submitted in two parts. **Part I** transfers \$5.8 million from the Procurement, Defense-Wide 05/07, appropriation to Research, Development, Test, and Evaluation, Defense-Wide, 05/06, appropriation for proper execution. **Part II** transfers \$1.0 million from Research, Development, Test, and Evaluation, Defense-Wide, 05/06, appropriation to the Operation and Maintenance, Defense-Wide, 05/05, appropriation for proper execution. This reprogramming action uses general transfer authority pursuant to section 8005 of Public Law 108-287, the Defense Appropriations Act, 2005; and section 1001 of Public Law 108-375, Ronald Reagan National Defense Authorization Act for FY 2005 and is determined to be necessary in the national interest. This action does not change the purpose for which the funds were originally appropriated.
