This reprogramming action transfers \$12.750 million from the Operation and Maintenance, Defense-Wide, 05/05, appropriation to the Research, Development, Test, and Evaluation, Defense-Wide, 05/06, appropriation for proper execution. This action uses general transfer authority pursuant to section 8005 of Public Law 108-287, the Department of Defense (DoD) Appropriations Act, 2005; and section 1101 of Public Law 108-375, the Ronald W. Reagan National Defense Authorization Act for Fiscal Year (FY) 2005, and is determined to be necessary in the national interest. This action does not change the purpose for which the funds were originally appropriated. This action meets all administrative and legal requirements of the Congress and these items have not previously been denied by the Congress.

Explanation: As in FY 2003 Congress provided additional funding to the Defense Logistics Agency (DLA) in the Operation and Maintenance, Defense-Wide appropriation specifically for "Commercial Technology for Maintenance Activities." This is the third year in a row that Congress has added funding for this program. However, this effort was executed within the DLA Research, Development, Test and Evaluation, Defense-Wide appropriation. Similar to FY 2003 when the Department realigned this funding (FY 03-12 IR) between accounts, this action transfers the funds from Operation and Maintenance, Defense-Wide, 05/05, appropriation to Research, Development, Test, and Evaluation, Defense-Wide, 05/06, appropriation for proper execution.
