Explanation: The Congress added FY 2005 Supplemental funding for Silver Fox Unmanned Aerial Vehicles (UAVs) for Naval Special Operations Forces. The Silver Fox UAV was determined to be not optimum for Special Operations Command (SOCOM) uses. The SOCOM will use \$2.5 million for the Aqua Puma UAV, and the remaining \$2.5 million will be transferred to the Navy for the Silver Fox Unmanned Aerial Vehicle Systems Proof-of-Concept demonstration in support of Navy Special Clearance Teams. Efforts funded will include: 1) upgrade and material delivery of four UAV Block B-4 systems; 2) program management support and documentation; 3) test/demonstration support; and 4) operator training and materials. This is a congressional special interest item.
