This reprogramming action is submitted for prior approval because it transfers \$195.0 million from the Operation and Maintenance, Defense-Wide, X appropriation to the Operation and Maintenance, Defense-Wide, 07/07, appropriation to finance global train and equip projects. This transfer is pursuant to section 1206 of Public Law 109-163, the National Defense Authorization Act for Fiscal Year (FY) 2006, as amended. This reprogramming action transfers funding in support of higher priority items, based on unforeseen military requirements, than those for which funds were originally appropriated. It meets all administrative and legal requirements.

Explanation: Funds are required to finance urgent section 1206 projects approved by the Secretaries of Defense and State. Section 1206 provides Combatant Commanders flexibility to work directly with partner nations to meet urgent and emerging military needs. Combatant Commanders stress this authority is a critical investment and supports military objectives to defeat terrorists, build security and stability, and reduce the risk of the U.S. being compelled to deploy armed forces. These projects will be notified to the Congress as required by section 1206. The Department will not initiate any 1206 projects prior to expiration of the 15-day congressional notification period.

Explanation: Pakistan and Jordan have lagged in submitting reimbursement requests to the Department thus delaying payments. As a result, the Department estimates that Title IX (Public Law 107-289) funds will be sufficient to finance current payments. Funds from the FY 2007 Supplemental, when appropriated, will be required to backfill this amount to make continued payments to Pakistan, Jordan, and other key cooperating nations for support provided to U.S. military operations.
