Explanation: Funding is required to begin the critical development of Ground Soldier System (GSS) (Increment 1) fielding to an Infantry Brigade Combat Team (IBCT); and the inclusion of voice and Position Location Information (PLI) via Rifleman Radio. Funding will provide much needed additional time given the technical complexity of developing and integrating a voice and data network in an IBCT equipped with GSS to include the integration of the Riflemen Radio. This additional time also keeps the program on schedule to support the recently announced acceleration of Future Combat System (FCS) capabilities to IBCTs and leverages FCS test events. Without the additional funding, GSS will not be available for the Initial Operational Test and Evaluation (IOT&E) and the FCS Spin Out 2 Limited User Test (LUT) scheduled in 4th Quarter FY 2010. The GSS IOT&E and LUT will be delayed until FY 2011, and the IOC will slip into FY 2013. The program is currently fully funded in FY 2009 through FY 2015. This is a new start.
