<u>Description</u>: The reprogramming of \$3.8 million into the Training Area Infrastructure — One Station Unit Training (OSUT) Area will allow the Army to construct the full authorized scope of the project through the award of fifteen bid options that were not previously awarded due to insufficient funding authority. This project will allow for the expansion of activities at the OSUT Maneuver Training Area by providing the needed infrastructure, including new training area tank trails, repair of existing area tank trails, low water crossings, fording sites, traffic signage, and a field training/staging area.

Justification: Additional infrastructure is needed at Fort Benning, Georgia to support its transformation into the Maneuver Center of Excellence (MCOE) in 2011. Accordingly, a contract was awarded within the Army's authority for cost variation on May 12, 2010, to construct critical scope items (87 percent of scope). Funding the full scope of this project will increase the cost to 123 percent of the program amount. Sufficient funding authority was not available to award the full authorized scope of the project, and thus, the project was awarded for the base bid only. This reprogramming request will fund the fifteen bid options that have not been awarded. Scope reductions cannot be made to adjust for the cost increases and still provide training area infrastructure that fully supports the Fort Benning training mission. If this reprogramming request is not approved, it will result in decreased training opportunities, less effective training, and inadequate access to new and existing training areas.

Description: This action will fund the construction of new Area Maintenance Support Activity (AMSA) Tactical Equipment Maintenance Facility (TEMF) buildings to replace those damaged at the Naval Support Activity Mid-South in Millington, Tennessee. The new facilities will include a maintenance shop, unheated storage building, and organization parking.

Justification: On 1 May 2010, the Army Reserve TEMF buildings at the Naval Support Activity Mid-South in Millington, Tennessee, were flooded with over 7 feet of storm water, causing interior, electrical, equipment, and structural damage. The buildings were condemned as a result of the flooding. Therefore, Army Reserve seeks to replace the facilities using Section 2854 of Title 10, which provides authority for the Army Reserve to replace the damaged facilities. In accordance with Section 2854, notification was provided to the Congressional Committees on or about July 23, 2010, to inform them of Army Reserve's intent to replace the facilities.

The Army Reserve would like to build the new facilities on higher ground outside the flooded area on Naval Support Activity Mid-South property in an effort to protect the life/health/safety of our Soldiers and civilians. The new facilities will comply with Energy Policy Act of 2005, Section 203 of the National Defense Authorization Act of 2007, and Executive Orders 13423 and 13351. In the meantime, ongoing maintenance operations are being conducted over 20 miles away at the United States Army Reserve maintenance facilities in downtown Memphis, TN that are small, overcrowded, and not anti-terrorism/force protection compliant.

<u>Description:</u> This emergency construction project repairs 310 linear feet (LF) of bulkhead and constructs 410 LF of new bulkhead along the eastern side of the pipe causeway that extends between Wharf Uniform and Pier Charlie at NS Guantanamo Bay. The causeway also provides a roadway for vehicular traffic to Pier Charlie.

Justification: The existing bulkhead and erosion control blanket that protects the eastern side of the causeway between Wharf Uniform and Pier Charlie are severely deteriorated with sections that have already failed. This situation has led to the erosion of the soil beneath the concrete foundation that supports the fuel lines along the causeway. The continued deterioration and erosion will lead to the structural failure of the foundation and potential fuel spill into the bay. Pier Charlie is the only pier with fuel unload capability. Therefore, the failure of the bulkhead and erosion control blanket will interrupt NS Guantanamo Bay's fueling capability. This also means that the base will not be able to operate the local power plant, which will interrupt their ability to generate electricity and fresh water.

This project is an urgent requirement. Deferral of the project until the next Military Construction Authorization Act would be threaten the NS Guantanamo Bay's mission, and is critically needed to protect the quality of the
