This reprogramming action is being submitted for prior approval because these actions use general transfer authority, exceed established reprogramming thresholds, affect congressional special interest items, and initiates a new start. This reprogramming action provides funding in support of higher priority items, based on unforeseen military requirements, than those for which originally appropriated; and are determined to be necessary in the national interest. They meet all administrative and legal requirements, and none of the items have previously been denied by the Congress. This reprogramming impacts the Military Intelligence Program (MIP).

Part I of this reprogramming action transfers \$40.552 million among Defense appropriations. This reprogramming action uses \$1.0 million of general transfer authority pursuant to section 8005 of P.L. 111-118, the Department of Defense (DoD) Appropriations Act, 2010; and section 1001 of P.L. 111-84, the National Defense Authorization Act, 2010.

<u>Part II</u> of this reprogramming action realigns \$12.240 million within Aircraft Procurement, Army, 09/11, appropriation and \$1.025 million within Procurement of Weapons & Tracked Combat Vehicles, Army, 09/11, appropriation.
