Explanation: Funds are required to ensure continuity of operations throughout Joint Improvised Explosive Device Defeat Organization (JIEDDO). Immediate civilian payroll requirements and contractual obligations must be paid. The only alternative is to shut down partial or total activities of one or more of the individual entities within JIEDDO. JIEDDO is minimally sized and structured to execute an efficient and effective ongoing sequence of processes and procedures between and through JIEDDO entities that provides comprehensive support to Combatant Commanders' urgent requests regarding Counter Improvised Explosive Device (C-IED) operations and tactics. Reductions in manpower or capability in any individual entity would therefore impact directly the overall responsiveness to the urgent requests of the Combatant Commanders.
