This reprogramming action is submitted for prior approval because it uses special transfer authority. This reprogramming action provides funding in support of higher priority items, based on unforeseen military requirements, than those for which originally appropriated; and are determined to be necessary in the national interest. They meet all administrative and legal requirements, and none of the items have previously been denied by the Congress.

This reprogramming action transfers \$21.8 million from the Operation and Maintenance, Defense-Wide, 12/12, appropriation to the Global Security Contingency Fund, 12/X, appropriation. This reprogramming uses \$21.8 million of special transfer authority pursuant to section 8089 of Division A of Public Law 112-74, the Department of Defense (DoD) Appropriations Act, 2012 and is in accordance with section 1207 of Public Law 112-81, the National Defense Authorization Act for Fiscal Year (FY) 2012.

Explanation: Funds are required to address issues to:

- 1. Develop the ability of Philippine National Police (PNP) entities in Mindanao to assume counterterrorism-focused law enforcement responsibilities, enabling the phased drawdown of U.S. Joint Special Operations Task Force-Philippines' presence and Assisting the Philippine Coast Guard and other security forces and maritime law enforcement organizations to establish and maintain a credible presence in the South China Sea, building the government's ability to host and support the increased U.S. rotational force presence in Asia (\$8.0M).
- 2. Develop the capacity of the Nigerian government to thwart the violent extremist organization known as Boko Haram which has linkages to Al Qaida in the lands of Islamic Maghreb by working to identify and train an effective counterterrorism force (\$2.0M).
- 3. Train and equip the Bangladesh Ministry of Defense and Ministry of Home Affairs to conduct counter terrorism operations across land and maritime environments (\$2.8M).
- 4. Assist Hungary, Romania, and Slovakia in achieving and maintaining a NATO standard deployable Special Operations Task Group (\$2.8M).
- 5. Train and equip Libya Special Operations Forces to counter and defeat terrorist and violent extremist organizations (\$6.2M).
